

UNITED STATES JCI SENATE 2019-2020 ANNUAL MEETING June 27, 2020 via "Zoom"





- Call to Order President Lawrence Pittman #53932 called the Annual Meeting for 2019-2020 year to order at 11:05 am EDT on June 27, 2020. The meeting was held via zoom due to COVID-19 Pandemic which made attendance in person impossible.
- II. Immediately, Secretary Susan Hatcher #58143 requested a motion for a 15-minute recess due to technical difficulties related to attendees limited to 100. Alabama JCI Senate seconded the motion and it was unanimously passed. No one was available at Zoom to contact (the US JCI Senate had paid for 500-person capacity for the meeting). It was noted that quorum had been met with state delegates roll call at 10:45 am EDT. Several state delegates proxied their votes to the other delegates and non-delegates were asked to leave the Zoom meeting so that all elected officers and all states could be represented during the annual meeting. Since there are no contested races for election of officers, President Lawrence with advice from Legal Counsel Stu O'Hara #39768, decided to move forward with annual meeting of the limited agenda to comply with the bylaws of the organization. The annual meeting is being recorded and will be available for all members to view. The annual meeting proceeded.
- III. President Lawrence called on Marsha Phillips #47528 who then reviewed protocol for "zoom" meetings.
- IV. President Lawrence called on Chaplain Bill Hossman #41293 for the invocation who led the senate members in a reflection.
- V. President Lawrence called on Chief of Staff Hal Williams #43912 to lead the Pledge of Allegiance and all joined in the pledge. President Lawrence indicated a special thanks to all Veterans, First Responders, Health Care workers and Social workers especially during these pandemic times.
- VI. President Lawrence called on Secretary Susan Hatcher #58143 for roll call. All state delegates were certified prior to the meeting and roll call taken prior to the meeting for voting purposes. Secretary Susan then called the remaining delegates on the Executive Committee.

 President Lawrence Pittman, Administrative Vice President Ariel Jones, Treasurer Mike Andrews, Secretary Susan Hatcher, Chairman of the Board Pete Reinecker, Legal Counsel Stu O'Hara (Ex-officio), Region I NVP Cyndi Hall, Region II NVP Patrick Mahaney, Region III NVP John Cotter, Region IV NVP Don Ebbitt, Region V NVP Will Chester, Region VI NVP Dave DeLaney, Region VII NVP Dawna Norfleet, Region X NVP Kris Fletcher were noted as present. The state delegates and proxies are noted in Exhibit 1. Quorum met with 95 votes delegate votes recognized.
- VII. **2020 National Convention** (Greensboro, NC) President Lawrence called on Chairman Crissie Lewis #72169, who indicated that the Governor of North Carolina had put a 3 week hold on any further order of easing up restrictions related to COVID-19 pandemic. President Lawrence then announced based on the Governor's order to continue the "stay at home" order in North Carolina through at least July 17, 2020 in consultation with Legal Counsel and discussion with some members that as President he had decided to cancel the Celebration of 2019-2020 and Convention scheduled for July 26-30, 2020. He then thanked the Committee as well as the NC JCI Senate for all their hard work on the convention. All registrations will be refunded as well as ads for program books by August 1. Program book will be available on-line.
- VIII. President Lawrence indicated that the amendments to the bylaws will be moved to the agenda for the Fall BOD meeting.
- IX. **2020-2021 Budget** President Lawrence called on Treasurer Mike Andrews #58312 to present the budget for 2020-2021. Mike presented the budget that had been approved by the Finance Committee and indicated he was presenting it to the BOD in accordance with Article X, Section 5 of the by-laws. X. **Elections:** For purposes of elections President Lawrence called on Chairman of the Board Report Pete Reinecker #11777 and his committee. With no further discussion, the motion passed unanimously. COB Pete then administered the oath of office to Ariel Jones #65423 as the 49th President of the US JCI Senate. COB Pete then yielded the floor to newly elected President Ariel for a few short comments and to administer the oath of office to the other new elected officers and National Vice Presidents.
