- VI. Approval of Agenda: Motion to approve the agenda made by Alabama, seconded by Region 6. Motion passed.
- VII. Welcome to Kentucky: Kentucky JCI Senate President Brad Blain #39993 welcomed everyone to Kentucky. He thanked co-chairmen Tracy Luttman and Will Chester and their committee for an outstanding job. If there are any problems, see Jerry Luttman or Jim Dulin.
- VIII. Introductions: President Mike announced that introductions will be held over to the banquet.

- IX. Secretary's Report: In the absence of Secretary Bruce Sostak #52655, President Mike Andrews handled this part of the agenda.
  - **A. Mentors:** Chief Editor Angie Jelinek #60570 thanked her staff for the outstanding job this year. Jackie Julien had great results raising money. The deadline for the next Mentors is July 11<sup>th</sup> by midnight.
  - **B.** E-News: Editor Marsha Phillips #47528 has finished serving 4 years in this position. She thanked Lowell Vahl for his assistance. The deadline for the next issue is July 1<sup>st</sup> at 5:00 pm.
  - **C. Webpage**: Webmaster Allison Geddes #74777 announced the website is up and running. The updated website will be available on July 1<sup>st</sup>. The form for directory submissions is available.
  - **D.** Social Media: Program Manager Kim Hubbell #68729 announced her report was on the web. She thanked everyone who submitted the blue shirt pictures.
  - **E. Approval of Winter BOD Minutes**: President Mike Andrews #58312 asked for approval. Motion by New York, seconded by Indiana. Motion passed.
- X. **Treasurer's Report:** Treasurer Hal Williams #43912 handled this portion of the agenda.
  - A. Finance Committee: Chairman Lawrence Pittman #53932 reported the committee met on Monday morning and reviewed Budget to Actual. Everything was in good shape. He thanked the committee members for their participation this year. The preliminary budget was reviewed and approved. No action is required by the Finance Committee. Budget approval will be held at the Fall BOD Meeting.
  - B. Membership Report: MIS Program Manager Gary Pittenger #24804 stated his report is on the web along with quarterly membership reports for the year. Gary reported that there has been 2 quarters of membership activity since the last meeting. We were at -7 at that point. March had 1,834 members due. We dropped 78 and added 124 for a net change of +46. Seven regions grew with Region 8 being the largest at +16. A total of 21 states grew with the largest being Kansas (+12), Tennessee (+11) and lowa (+6). June had 2,478 due. We dropped 162 and added 186 for a net growth of +24. Seven regions grew with Region 8 being the largest at +27 and 21 states grew with Kansas being the largest at +24. The US JCI Senate finished at +63 for the year. Our total membership is 8,077. A total of 6 regions grew and 23 states grew for the year. Gary thanked assistant Dawna Norfleet for her efforts during the year. Dawna Norfleet thanks Gary for his assistance in helping her learn the membership process.
  - **C.** Budget to Actual Report: Treasurer Hal Williams #43912 accepted a motion by Washington, seconded by Region 6 to approve the report. Motion passed.
  - **D.** Interim Budget 2022-23: Treasurer Hal Williams #43912 announced the interim budget will be voted upon at the Fall BOD Meeting in Golden, CO.
